to launch of a competitive entrance examination into the in the **third year** of the Engineering Sciences training course of the **National Advanced School of Engineering of the University of Maroua**, and to fix the number of places available for the 2020-2021 academic year.

THE MINISTER OF STATE, MINISTER OF HIGHER EDUCATION,

Mindful of Decree n° 2017/318 of 27 June 2017 appointing a Vice-Chancellor and Rectors in some State Universities;

Mindful of Decree n° 2017/350 of 06 July 2017 bringing a change of name of Higher Institute of the Sahel to National Advanced School of Engineering of Maroua;

Mindful of Decree n° 2020/274 of 11 May 2020 appointing reorganization of National Advanced School of Engineering of Maroua;

Mindful of order n°20-00407/MINESUP/SG/DAUQ/SDEAC/SE of 26 May 2020 modifying order n°2000106/MINESUP/SG/DAUQ/SDEAC/SE of 17 March 2020 organize the calendar of competitive entrance examinations into Faculties, Schools and Institutes of Cameroon State Universities for 2020-2021 academic year;

On the proposal of the Rector of the University of Maroua;

DECIDES:

Article 1: A competitive entrance based on file study for the admission of one hundred and seventy (170) students in the third year of the Engineering Sciences training course of the National Advanced School of Engineering, University of Maroua for the 2020-2021 academic year, in the following fields:

- Agriculture, Livestock and Derived Products ;
- Renewable Energy ;
- Civil Engineering and Architecture;
- Hydraulics and Water Management;
- Computer Sciences and Telecommunications;
- Environmental Sciences.

Article 2:

- (1) The examination is organised for Cameroonians holders of the bachelor, HND, DUT or the BTS Certificates, as well as to students who have completely finished with the two first year of the universities degree, as requested for each course or any other equivalent diploma recognize as equivalent by the Minister of Higher Education.
- (2) The table below shows the required diplomas or certificates that a candidate must have in order to be qualified to register for the competitive entrance examination:

Computer Sciences and Telecommunications	Diploma of Bachelor, DUT / BTS / HND or Wildlife Specialty Diploma, and any other diploma recognized as equivalent by the Minister of Higher Education allowing you to the study in the chosen specialty
Environnemental Sciences	Diploma of Bachelor, DUT / BTS / HND or Wildlife Specialty Diploma, and any other diploma recognized as equivalent by the Minister of Higher Education allowing you to the study in the chosen specialty

Article 3:

- (1) Civil servants or workers who are successful in the competitive examination must pay fee per year for their training, the amount is indicated by a particular order.
- (2) Foreign candidates proposed for the training by their government are admitted under the same academic conditions as above depending on the number of places available.

Article 4: The application files shall comprise the following documents:

- A printed application form duly filled in by the candidate on the websites : www.minesup.gov.cm or <http://www.univ-maroua.cm> or <http://www.enspm.univ-maroua.cm>.

- A certified photocopy of the national identity card;
- A certified photocopy of the birth certificate dated not more than three (03) months;
- Transcripts of the Probatoire or GCE / OL, the Baccalaureate or the GCE / AL signed or certified by the competent services;
- A certified photocopy of the baccalaureate or GCE / AL, or any other diploma recognized equivalent by the Minister of Higher Education, dated not more than three (03) months;
- A medical certificate is issued by-a medical officer from the Administration testifying that the candidate is physically and medically fit for teaching;
- An extract from the criminal record (bulletin n ° 3) dated not more than three (03) months;
- An A4 envelope postal stamped at 1000 FCFA and addressed to the candidate;
- Four (04) passport-size photographs (4x4);
- A receipt of twenty thousand (20,000) CFA as registration fee representing the expenses of exam (payment or transfer fee not included) to be paid into the account of the National Advanced School of Engineering of the University of Maroua, **Account Number 37160230501- 69 issued by COMMERCIAL BANK-CAMEROUN**. Competition fees are not refundable;
- Working Candidates should attest their experiences in the field;

Article 5: Holders of foreign diplomas shall submit either the equivalence or the receipt showing that they have applied for the equivalence of their diplomas or certificates issued by the Minister of State, Minister of Higher Education. However, their final admission and the award of a diploma or attestation of completion at the end of their training may be acquired only upon presentation within the time limits set by the competent authority, of the text granting equivalence to their diploma, and obtained from the Minister of State, Minister of Higher Education by the candidate.

Article 6: The completed application file should be submitted either to the Regional Delegations of Secondary Education, or the National Advanced School of Engineering of the University of Maroua, or the Department of Meteorology, Climatology, Hydrology and Pedology of the Advanced School of Engineering in Kousseri or to the Yaoundé-Antenna of the University of Maroua, on or before the **07 October 2020** at 3.30 p.m. precisely.

Article 7: The number of places:
